# Public Consultation on the Proposed Main Modifications to the Kent Minerals and Waste Local Plan 2024-39

The Kent Minerals and Waste Local Plan 2024-39 was submitted to the Secretary of State for Independent Examination on 17 May 2024 and the Public Hearings took place in September 2024. Following the close of the Hearings, a number of Main Modifications have been identified that are required in order to ensure that the Local Plan is sound and legally compliant.

Kent County Council has published the Main Modifications to the Kent Minerals and Waste Local Plan 2024-39, along with the accompanying Sustainability Appraisal for representations and Members are asked to consider the content and make representations which are to be submitted by **midnight on Thursday 28<sup>th</sup> November 2024.** Members have previously been provided with the details of the consultation together with guidance notes.

The Clerk will confirm that all potential candidates qualify to stand for the position and candidates will be informed of the result at the meeting. The Clerk will ask the successful applicant to complete required documentation including a Declaration of Acceptance of Office & Declaration to Comply with Member Code of Conduct; Code of Conduct and Notification of Disclosable Pecuniary Interests.
